

Dear National Adoption Conference Attendees,

Meeting virtually is not how we originally conceived of NCFA's 40th anniversary National Adoption Conference. Developing a Comprehensive Approach to Post-Adoption Services and Supports

Adoptive families face challenges and have needs that manifest at different times over the course of life. Yet families often struggle to find appropriate help, particularly in rural areas or when problems arise years following the adoption. In this session, the presenters will describe how Virginia Department of Social Services (VDSS) conducted a needs assessment for post-adoption services. Attendees will learn about: how the needs assessment informed the creation of a coordinated, comprehensive service strategy; the tools, products, and communications strategy developed to disseminate this information to relevant audiences; and how VDSS leveraged a revised funding structure to implement the new service array.

The Role of Pre-Placement Medical Review in Contemporary Adoptions

Setting Expectations, Assessing a Child's Needs, and Supporting Successful Family Formation

Adoption in the U.S. has evolved to where a majority of children now available for placement have either recognized medical problems or are vulnerable to developing a variety of disabilities. This session traces the history of pediatric health care providers in the adoption process and discusses how new knowledge on adversity in early childhood has expanded our understanding of risk factors in adopted children. Finally, the process of pre-adoption medical evaluation is outlined, the goal of which is to assist parents in making a well-reasoned decision on whether they have the resources to provide for their new child's needs.

Preparing Children Already in the Home for New Foster/Adoptive Siblings

As a foster/adopt agency, it is just as important to adequately prepare children for the arrival of foster/adopt siblings as it is to prepare resource parents. In this session, a day-long training for children will be presented. The training of children is age appropriate, activity based, and prepares them for the arrival of siblings. It also creates a space for them to ask questions, dispel myths, and to get advice about how to address their peers when questions arise about new family members.

Search and Reunion in Adolescence

The media often presents the dramatic and heartwarming aspects of search and reunion, but the reality is much more complex. These stories often focus on adult adoptees meeting birth family members. Today, adolescent adoptees increasingly are seeking birth family contact. The old refrain of “wait till you’re 18” is a thing of the past. 
