Introduction

This Adoption by the Numbers report from the National Council For Adoption (NCFA) presents data on the number of adoptions in the United States in 2021 and 2022. National and state-level data are provided on the number of private domestic adoptions, intercountry adoptions, and adoptions from foster care.

Additionally, while not all state and national adoption data are available for 2023, data are provided when available. This research report also includes comparisons and updates to 2019 and 2020 adoption data originally provided in the previous *Adoption by the Numbers* report. In addition to recent updates, this report provides historical information on the number of intercountry adoptions and adoptions from foster care in the United States since the year 2000.

The primary contribution of this report is a national estimate of the number of private domestic, non-stepparent adoptions in the United States in 2021 and 2022. In 2021, the estimated number of adoptions was 25,949, and in 2022 it was 25,503 adoptions.

This report includes the research team's methodology, findings, discussion, and policy considerations for private domestic adoptions as well as for intercountry adoptions and adoptions from foster care. The special focus on private domestic adoption is due to the specific complexities of accessing and reporting on states' adoption data.

This report compiles and shares pertinent adoption data that are not otherwise gathered or reported on by any government or non-government organization. The U.S. Children's Bureau's Child Welfare Information Gateway (CWIG) reports that "there is no single source for the total number of children adopted in the United States, and there is currently no straightforward way of determining the total number of adoptions."¹ This is because the federal government only collects data on adoptions with public agency involvement (i.e., adoption from foster care aggregated and reported by the U.S. Department of Health and Human Services)² and intercountry adoptions (reported by the U.S. Department of State).^{3,4} Data on private domestic adoptions are not gathered or reported at a national level. Instead, these data are only available from individual states, many of which do not routinely report or aggregate such information. Of those that do, their collection and reporting is not consistent or uniform, making it challenging to collect, compare, and interpret private domestic adoption numbers.

This report represents the most comprehensive estimate of private domestic adoptions in the United States. This information has significant policy implications, and it is crucial for the federal government to begin tracking and reporting on these data annually. The report and the trends it identifies may be used to determine how to allocate child welfare funding, provide post-adoption support to birth parents and adoptive families, and to identify areas in need of support or reform.

Data Collection Methods

NCFA's most recent Adoption by the Numbers report, published in 2022, provided data for the years 2019 and 2020. That report utilized a new approach to data collection and methodology to increase accuracy in reporting. This report follows the same data collection process as the previous report, establishing a four-year period of comparable data that future reports will continue to build upon. For states with data available for 2023 at the time of data collection, there is an additional year of comparable data.

The research team began by evaluating publicly available state reporting on adoptions, followed by outreach to officials from the 50 U.S. states and Washington, D.C.⁵ Reporting was gathered from sources including courts, vital records offices, and human services departments. Detailed information on data sources is presented for each state (see Appendix A).

For the number of private domestic adoptions, the Court Statistics Project (CSP) was a key source of information. The CSP offers annual statistics on state court caseloads, aggregated and provided by the states. CSP data may differ from what states report in other documents due to the data transformation the CSP makes for cross-state comparisons.6 Since private domestic adoptions are not aggregated or reported at a national (and sometimes state) level, methodologies for data collection and reporting vary. For instance, states utilize different reporting periods (e.g., state fiscal year [SFY], calendar year [CY], or federal fiscal year [FFY]), different approaches for categorization (most do not differentiate between stepparent, other kinship, and nonrelative adoptions, nor do they indicate whether embryo adoptions or intercountry re-adoptions are included), and some report adoption numbers based on adoption filings or hearings, rather than finalizations. Specifically, California does not report on state-level adoption data; therefore, the research team conducted outreach to each of California's 58 county superior courts.

For the number of children adopted from foster care, the primary data source is the Adoption and Foster Care Analysis and Reporting System (AFCARS).7,8 Among many other data points, these reports include national and state-level estimates of adoptions from foster care. Every six months, the federal government requires that all state and tribal child welfare agencies provide case-level information on all children that are in foster care or have been adopted with child welfare agency involvement. States are permitted to resubmit AFCARS data; therefore, estimates often slightly change over time. While the Children's Bureau does not retroactively update reports, AFCARS reports since 2013 have presented adoption totals for the past five-year period, including any updated data. To include the most up-todate information, annual totals were collected from the most recent AFCARS report.9 These reports use the federal fiscal year.10

For the number of intercountry adoptions, the sole data source is the U.S. Department of State's adoption statistics and annual reports.^{11, 12} Among other data points, these reports include national and state-level data on incoming intercountry adoptions. The U.S. Department of State's Office of Children's Issues collects and shares these data annually, as required by the Intercountry Adoption Act of 2000 (IAA). These reports use the federal fiscal year.¹³ The Department of State's annual reporting was initiated in 2008 but only included partial data for that year; therefore, data collection for the historical intercountry adoption data from 2000 to 2008 was instead acquired from the Department of State's adoption statistics page, and 2009–2023 data are from the annual reports. For states that did not have adequate statewide public reporting, individual outreach was conducted, and state officials were sent the survey instrument or a request for specific data items from the survey instrument. The research team reached out to representatives from 32 states and the District of Columbia and received full or partial data from all but four of the 32 states. The other four states either did not have the requested data or did not respond to inquiries.

The survey process followed the same methodology as the previous report. The research team began by reaching out to representatives contacted for the previous report. If initial contacts did not respond, the team extended outreach to other relevant staff and offices within the state. Most contacts included staff within state agencies responsible for children and family services, vital statistics offices, or the family court system.

Prior to disseminating the survey, the research team reviewed the survey instrument used in the previous report¹⁴ and determined that the survey instrument remained an adequate tool for data collection. Adjustments were made to update the data collection period and remove a few reporting items, including the number of non-foster care adoption subsidies and whether the state tracks information about adoption service providers involved in adoption cases. The survey instrument was then finalized (see Appendix C).

The survey requested data on public and private domestic adoptions for 2021, 2022, and 2023, with a primary focus on private adoptions. Specifically, the questionnaire gathered information on a state's total number of adoptions (excluding intercountry adoptions), the number of adoptions from foster care, and the number of private domestic adoptions. It also gathered details on the number of private domestic adoptions that were stepparent adoptions, adoptions by other relatives, or non-relative adoptions, and captured the reporting period of the data provided.

The Children's Bureau reported data quality concerns with Puerto Rico's data, and therefore only included their data in AFCARS reports from 2018 through 2022. For consistency throughout this report, data from Puerto Rico have been excluded.

¹³ Discrepancies were noted in Department of State data, as annual reports often provided different intercountry adoption totals than the Department's adoption statistics pages. An inquiry was sent to their staff and, while their office did not provide clarification on these discrepancies, they recommended deferring to data presented in the annual reports. No recommendations were provided for a reliable data source prior to initiation of the annual report in 2009. For historical data from 2000-2008, the researchers utilized data available on the Department's adoption statistics page under "U.S. States".

Data Analytic Methods

This report primarily relied on data from publicly available state reporting. When multiple data sources were available, they were first prioritized by specificity and reliability.¹⁵

Many sources utilized timeframes that were not consistent with one another (e.g., calendar year vs. state fiscal year vs. federal fiscal year). If multiple sources of reliable data were available, sources were selected based on which had the greatest reporting timeframe overlap. Since each state's intercountry adoption data and most states' adoption from foster care data were sourced from federal reporting, private domestic adoption data sources were often selected to align with this reporting period. Sources utilizing the calendar year were usually prioritized over the sources utilizing the state fiscal year because this period often overlapped with more of the federal fiscal year. When there were substantial differences in data points across sources, the research team evaluated and selected sources based on consistency with prior reporting, data scope, and specificity. Detailed reasoning on source selection is provided for each state (see Appendix A).

For states where individual outreach was conducted, the reported data were compared to other available data sources for the state. While most states reported the number of adoptions from foster care, many did not include total or private adoption data. In cases where states provided two of the three data points, the missing data point was calculated.¹⁶

Data analysis for the state of California is unique, as the state does not aggregate or report on adoption data. Outreach was conducted to the state's 58 superior courts, and adoption estimates were made using data available from the 46 county courts that responded. The child population in the responding counties was divided by the child population of California to calculate the proportion between the child population in these counties and the child population of the entire state.¹⁷ This proportion was used to estimate the total number of domestic adoptions in California by dividing the total number of adoptions reported in the responding counties by the calculated proportion.

The national estimate of stepparent adoptions was calculated by imputing data based on information from the limited number of states (seven) that clearly distinguished between stepparent and non-stepparent private domestic adoptions; due to questions of data accuracy, only six of the seven states' data were used in making this calculation. These figures were used to calculate the average percentage of private domestic adoptions that are stepparent adoptions. This percentage was then applied to the total number of private domestic adoptions in states that did not differentiate stepparent adoptions.

In gathering adoption data from 2019 through 2023, the researchers were able to re-evaluate previous estimates from NCFA's prior report focused on 2019 and 2020 domestic adoption numbers. Fourteen states are different in this updated report: Alaska, Arkansas, Colorado, Delaware, Hawaii, Idaho, Indiana, Kansas, Maryland, Missouri, Nebraska, New York, South Carolina, and Utah. Changes were prompted primarily by data availability (e.g., previously, private domestic adoption data were based on a calendar year, and adoptions from foster care data were based on state fiscal year, while more current data allow for use of the same reporting period) and the desire for better year-to-year comparison.

Considering the changes to the domestic adoption data for 14 states, the research team also recalculated the stepparent adoption approximations for 2019 and 2020. In the previous report, data were used from nine states—Alaska, Connecticut, Kentucky, Louisiana, Montana, North Carolina, Oregon, Vermont, Virginia—and the District of Columbia. The current report's stepparent calculation no longer uses Alaska's stepparent data in calculating the national estimates, since its 2019 and 2020 data was updated.

Additionally, 2023 data were not yet available from all states; in particular, NCFA was missing private domestic adoption data for nine states. To estimate national data, the research team calculated the proportions of private domestic adoptions made up by these nine states in 2021 and 2022. The two proportions were averaged, and this average was applied to the sum of private domestic adoptions reported in the other 41 states and D.C. This gave an estimate for the number of private domestic adoptions nationwide in 2023 (see page 7).

Findings: National-Level Data

This section presents nationwide estimates for the total number of adoptions, as well as the number of domestic adoptions, private domestic adoptions, intercountry adoptions, and adoptions from foster care in 2019, 2020, 2021, and 2022.¹⁸ Data for 2023 are also presented, where available. State-level findings are presented in Appendix A.

Total Adoptions

An estimate for the total number of adoptions in the U.S. in 2019, 2020, 2021, and 2022 is provided. This includes private domestic adoptions, intercountry adoptions, and adoptions from foster care (i.e., public adoptions), and excludes stepparent adoptions.

In 2022, an estimated 80,598 children were adopted in the U.S., excluding stepparent adoptions.

This decreased 1.52% from the previous year.¹⁹ In 2022, adoptions from foster care made up 66.48% of total adoptions, while private domestic non-stepparent adoptions made up 31.64%, and intercountry adoptions made up 1.88%. The total number of adoptions, including stepparent adoptions, was 106,196.

In 2021, an estimated 81,839 children were adopted in the U.S., excluding stepparent adoptions.

This increased 1.93% from the previous year. In 2021, adoptions from foster care made up 66.12% of total adoptions, while private domestic non-stepparent adoptions made up 31.71%, and intercountry adoptions made up 2.17%. The total number of adoptions, including stepparent adoptions, was 108,426.

In 2020, an estimated 80,289 children were adopted in the U.S., excluding stepparent adoptions.


This decreased 14.38% from the previous year. In 2020, adoptions from foster care made up 71.99% of total adoptions, while private domestic non-stepparent adoptions made up 25.99%, and intercountry adoptions made up 2.02%. The total number of adoptions, including stepparent adoptions, was 101,165.

In 2019, an estimated 93,775 children were adopted in the U.S., excluding stepparent adoptions.

In 2019, adoptions from foster care made up 70.48% of total adoptions, while private domestic non-stepparent adoptions made up 26.36%, and intercountry adoptions made up 3.16%. The total number of adoptions, including stepparent adoptions, was 121,465.


Estimated Number of Children Adopted in the U.S.

Domestic Adoptions

An estimate for the total number of domestic adoptions in 2019, 2020, 2021, and 2022 is provided. This includes private domestic adoptions and adoptions from foster care (i.e., public adoptions), and excludes stepparent adoptions. Different timeframes (e.g., state fiscal year, calendar year) were used in the estimates for the number of private adoptions. The reporting period for adoptions from foster care is the federal fiscal year.

In 2022, an estimated 79,082 children were adopted domestically in the U.S., excluding stepparent adoptions.

This decreased 1.22% from the previous year. In 2022, the total number of domestic adoptions comprises 67.75% public adoptions and 32.25% private adoptions. The total number of domestic adoptions, including stepparent adoptions, was 104,680.

In 2021, an estimated 80,060 children were adopted domestically in the U.S., excluding stepparent adoptions.


This increased 1.77% from the previous year. In 2021, the total number of domestic adoptions comprises 67.59% public adoptions and 32.41% private adoptions. The total number of domestic adoptions, including stepparent adoptions, was 106,647.

In 2020, an estimated 78,671 children were adopted domestically in the U.S., excluding stepparent adoptions.

This decreased 13.37% from the previous year. In 2020, the total number of domestic adoptions comprises 73.47% public adoptions and 26.53% private adoptions. The total number of domestic adoptions, including stepparent adoptions, was 99,547.

In 2019, an estimated 90,809 children were adopted domestically in the U.S., excluding stepparent adoptions.

Non-stepparent domestic adoptions comprises 72.78% public adoptions and 27.22% private adoptions. The total number of domestic adoptions, including stepparent adoptions, was 118,499.

Private Domestic Adoptions

An estimate for the total number of private domestic adoptions, excluding stepparent adoptions, in the U.S. in 2019, 2020, 2021, and 2022 is provided. The number of private domestic adoptions, including that of stepparents is provided for 2023. **This is a subset of domestic adoptions represented in the previous section**. The reporting period for private domestic adoptions varies (e.g., state fiscal year, calendar year).

For 2023, due to limited state-level data, estimates differentiating between stepparent and non-stepparent private domestic adoptions could not be provided.

In 2023, the total number of private domestic adoptions was 50,544, including both stepparent and non-stepparent adoptions. This estimate is based on data from 41 states and D.C.

In 2022, an estimated 25,503 children were adopted via private domestic adoption in the U.S., excluding stepparent adoptions.

This decreased 1.72% from the previous year. The total number of private domestic adoptions was 51,101, which comprises 49.91% non-stepparent adoptions and 50.09% stepparent adoptions.

In 2021, an estimated 25,949 children were adopted via private domestic adoption in the U.S., excluding stepparent adoptions.

This increased 24.34% from the previous year. The total number of private domestic adoptions was 52,536, which comprises 49.39% non-stepparent adoptions and 50.61% stepparent adoptions.

In 2020, an estimated 20,869 children were adopted via private domestic adoption in the U.S., excluding stepparent adoptions.

This decreased 15.58% from the previous year. The total number of private domestic adoptions was 41,745, which comprises 49.99% non-stepparent adoptions and 50.01% stepparent adoptions.

In 2019, an estimated 24,720 children were adopted via private domestic adoption in the U.S., excluding stepparent adoptions.

The total number of private domestic adoptions was 52,410, which comprises 47.17% non-stepparent adoptions and 52.83% stepparent adoptions.

Adoptions from Foster Care

Data for the total number of adoptions from foster care (i.e., public domestic adoptions) in the U.S. in 2019, 2020, 2021 and 2022 are provided. **This is a subset of domestic adoptions.** The reporting period for this data is the federal fiscal year.

The research team utilized AFCARS data for national-level trends, however state sources were often used for state-level data. As a result, state-level data in Appendix A slightly vary from the totals presented in this section. Additionally, AFCARS reports include data for Puerto Rico, which have been excluded from the totals provided below.²⁰

In 2022, a total of 53,579 children were adopted from foster care in the U.S.

This decreased 0.98% from the previous year. This trend was observed in 28 states and D.C., while adoption numbers increased in 22 states.

In 2021, a total of 54,111 children were adopted from foster care in the U.S.


This decreased 6.39% from the previous year. This trend was observed in 32 states, while adoption numbers increased in 18 states and D.C.

In 2020, a total of 57,802 children were adopted from foster care in the U.S.

This decreased 12.54% from the previous year. This trend was observed in 39 states, while adoption numbers increased in eight states and D.C. and remained the same in three states.

In 2019, a total of 66,089 children were adopted from foster care in the U.S.

This increased 4.89% from the previous year.







Historical Data: Adoptions from Foster Care (2000–2022) ^{21, 22, 23}

This section presents historical data from 2000 to 2022. Adoptions from foster care have ranged between approximately 50,000-67,000 per year since 2000. While the trends have varied, adoptions consistently increased from 2014 until their peak in 2019, which totaled 66,089 adoptions. Since that time, adoptions from foster care have consistently declined. Most notably, adoptions from foster care declined 12.54% from 2019 to 2020 but did not recover in the years following the COVID-19 pandemic. As of 2022, the number of adoptions from foster care was 53,579.

Intercountry Adoptions

Data on the total number of incoming intercountry adoptions in the U.S. in 2019, 2020, 2021, 2022, and 2023 are provided. The reporting period for this data is the federal fiscal year.

The research team utilized the Department of State's Annual Report on Intercountry Adoption and adoption statistics page. These sources include data for adoptions completed in U.S. territories and by Americans residing overseas, which have been excluded from data presented below from 2008 through 2023.²⁴

In 2023, a total of 1,274 children were adopted into the U.S. via intercountry adoption.

This decreased 15.96% from the previous year. This trend was observed in 32 states, while adoption numbers increased in 13 states and remained the same in four states and D.C.

In 2022, a total of 1,516 children were adopted into the U.S. via intercountry adoption.

This decreased 14.78% from the previous year. This trend was observed in 32 states, while adoption numbers increased in 13 states and D.C. and remained the same in five states.

In 2021, a total of 1,779 children were adopted into the U.S. via intercountry adoption.


This increased 9.95% from the previous year. This trend was observed in 34 states, while adoption numbers decreased in 16 states and D.C.

In 2020, a total of 1,618 children were adopted into the U.S. via intercountry adoption.

This decreased 45.45% from the previous year. This trend was observed in 47 states and D.C., while adoption numbers increased in two states and remained the same in one state.

In 2019, a total of 2,966 children were adopted into the U.S. via intercountry adoption.


This decreased 26.64% from the previous year.

This section presents historical data afrom 2000 to 2023. The number of intercountry adoptions has been decreasing since it reached its peak of 22,989 adoptions in 2004. In 2023, the number of intercountry adoptions was 1,274, representing the fewest number of placements on record.

Adoption Trends

The landscape of adoption has shifted significantly over the past five years. A variety of global and national events, such as the COVID-19 pandemic, historical shifts in international adoption practices, and the landmark *Dobbs v. Jackson Women's Health Organization* decision, have raised significant questions from the wider community about how adoption trends may continue to change.

As described in the previous Adoption by the Numbers report, adoptions declined significantly between 2019 and 2020, reflecting early effects of the pandemic. During this period, private domestic, non-stepparent adoptions declined 15.58%; intercountry adoptions declined 45.45%; and adoptions from foster care declined 12.54%. In comparison, live births in the United States declined 4% between 2019 and 2020.²⁶

With three additional years of data, we can put these declines in context. Adoptions from foster care and intercountry adoptions continue to decline. Private domestic non-stepparent adoptions have increased since recovering from a drop in adoptions during the onset of the COVID-19 pandemic, growing by 3.17% between 2019 and 2022. Intercountry adoptions have

declined 57.05% since 2019, with a total of only 1,274 adoptions in 2023. Adoptions from foster care have steadily declined, with an 18.93% decrease from 2019 to 2022.

As a comparison, while live births in the United States also experienced a decline during the onset of the pandemic (from 2019 to 2020), this was followed by an increase of 1% from 2020 to 2021, and almost no change from 2021 to 2022. ²⁷ Live births declined an overall 2% from 2019 to 2022, with a total of 3,667,758 live births in 2022. ²⁸ In 2019, there were 6.6 non-stepparent private domestic adoptions per 1,000 live births, while 2020 saw a decline to 5.8 per 1,000 live births. This was followed by an increase to 7.1 non-stepparent private domestic adoptions per 1,000 live births in 2021, and then a slight decrease to 7.0 per 1,000 live births in 2022.²⁹ This indicates that fewer than one percent of infants were placed for private domestic adoption in 2022.³⁰ In addi-

tion to the influences of COVID-19, other factors have also greatly influenced adoption rates since 2019. Notably, China and Ukraine have historically been among the largest sending countries for intercountry adoptions. However, in 2020, China suspended the processing of intercountry adoptions, and in 2024, the country formally ended its intercountry adoption program.^{31, 32} As a result, adoptions from China dropped to a total of 202 adoptions in 2020, zero adoptions in 2021 and 2022, and 16 adoptions in 2023. This compares to 819 adoptions from China in 2019 and 7,903 adoptions at its peak in 2005. Additionally, the Russian invasion of Ukraine in February 2022 severely limited the processing of intercountry adoptions from Ukraine. This led to significant declines, with the total number of adoptions from Ukraine decreasing by 96.64%, from 298 adoptions in 2019 to 10 adoptions in 2023.

Additionally, the landmark *Dobbs v. Jackson Women's Health Organization* decision, which overturned Roe v. Wade in June 2022, has raised questions about the impact of altered abortion access on adoption trends. However, statistical evidence is not yet available to assess the impact of this decision on adoptions in the U.S. This report documents a slight decline of 1.72% in non-stepparent private domestic adoptions from 2021 to 2022. While data on non-stepparent private domes-tic adoptions after 2022 are not yet available, estimates of the number of private domestic adoptions (including that of stepparents) from 2022 to 2023 reflect a very similar trend, with a slight decline of 1.09%.³³ As more data become available from states, more reliable and comprehensive trends can be examined.

Policy Recommendations

This section offers recommendations for legislation and regulations that support and strengthen ethical, equitable, and evidence-based adoptions practices and prioritize the well-being and safety of children.

Federal Reporting of Private Domestic Adoptions

In the 118th Congress (2023-2024) the Adoption Counts Act (H.R. 6700) was introduced with the purpose of requiring states to provide information about the number of private domestic adoptions from each state. Such legislative efforts should be continued until there is accurate, reliable annual data on the number of private domestic adoptions in the United States. The federal government provides state court systems with enormous financial support for the work they conduct, including child and family welfare cases. State court systems are already processing adoption cases and therefore have the ability to track and report on the number of private domestic adoptions that are finalized without significant burden. These systems can, and should, track whether the placement is made to a relative, a stepparent, or unrelated parents; they can also document if the adoptive placement was an interstate placement. Such information would allow researchers to better understand trends in the field and provide policymakers with accurate information for creating policies impacting vulnerable populations.

Discretionary Funding to Support Adoption-Informed Education

Inaccurate information about adoption may be a significant reason expectant parents do not consider adoption among their options in response to an unplanned pregnancy. States and the federal government can fund education for healthcare workers, social workers, and other professionals who are likely to be in roles of communication with and support for expectant parents. Additionally, public schools can include fact-based, non-directive information about adoption in sexual health education curricula, including information about the rights expectant parents have in choosing the adoptive parents as well as the prevalence of open, ongoing relationships between birth parents and adoptive families.

Conclusion

National Council For Adoption (NCFA) periodically publishes a comprehensive report on U.S. adoption statistics. This report aims to provide helpful data for the public, media members, policymakers, and child welfare researchers. This is especially the case for private domestic, non-stepparent adoption data, as no other research estimates are available. The task of collecting and estimating this state and national-level adoption data remains exceedingly complex, though Congress has the ability to resolve this issue. In addition to providing new data estimates, this report updates prior estimates for 2019 and 2020, and it is likely that future research will lead to additional updates of the estimates provided in this report as well. We welcome suggestions, corrections, and additional feedback to enhance the quality and accuracy of these findings.

Data are reported on adoption from foster care, private domestic adoption, and intercountry adoption for 2019, 2020, 2021, 2022, and 2023, where available. Estimates of the total number of state-level adoptions per year are also included by taking the sum of the three types of adoption provided. Distinctive data for stepparent and non-stepparent private domestic adoptions are also provided where available.

Updated Data!

*Asterisks denote updates to adoption statistics presented in the previous Adoption by the Numbers report, which covered 2019 and 2020 data. Explanations for the changes are provided in the text.

Alabama

In 2023, an estimated 2,218 children were adopted in Alabama. This decreased 6.02% from the previous year. In 2023, adoptions from foster care made up 33.41% of total adoptions, while private domestic adoptions made up 65.42%, and intercountry adoptions made up 1.17%. The total number of adoptions from foster care was 741, which decreased 3.77% from the previous year. The total number of private domestic adoptions was 1,451, which decreased 6.33% from the previous year. Lastly, the total number of intercountry adoptions was 26.

In 2022, an estimated 2,360 children were adopted in Alabama. This decreased 7.05% from the previous year. In 2022, adoptions from foster care made up 32.63% of total adoptions, while private domestic adoptions made up 65.64%, and intercountry adoptions made up 1.74%. The total number of adoptions from foster care was 770, which decreased 1.66% from the previous year. The total number of private domestic adoptions was 1,549, which decreased 8.83% from the previous year. Lastly, the total number of intercountry adoptions was 41.

In 2021, an estimated 2,539 children were adopted in Alabama. This increased 42.16% from the previous year. In 2021, adoptions from foster care made up 30.84% of total adoptions, while private domestic adoptions made up 66.92%, and intercountry adoptions made up 2.24%. The total number of adoptions from foster care was 783, which decreased 3.81% from the previous year. The total number of private domestic adoptions was 1,699, which increased 85.28% from the previous year. Lastly, the total number of intercountry adoptions was 57.

Reporting Period


All 2021-2023 data for Alabama covered the state fiscal year.

Data Sources

NCFA received data on the total number of domestic adoptions of children aged zero to 17 in Alabama during state fiscal years 2021, 2022, and 2023 from the Statistical Analysis Division of the Alabama Department of Public Health (ADPH). The number of adoptions within this total that were adoptions from foster care was collected from the Alabama Department of Human Resources Annual Reports.³⁵ The number of private adoptions was estimated by subtracting the number of

adoptions from foster care from the total number of domestic adoptions.

Updates to 2019 and 2020 Data

Between State Fiscal Year (SFY) 2019 and 2020 and SFYs 2021 through 2023, the source of adoption from foster care data is the same, but the source for the total domestic adoption data is not. In particular, the previous Adoption by the Numbers estimated the total number of domestic adoptions based on figures from prior years and statistics on disposed domestic cases as reported by the Alabama Administrative Office of Courts.³⁶ By contrast, the numbers for domestic adoptions in SFYs 2021 through 2023 are exact figures provided by representatives in ADPH. Additionally, the total number of domestic adoptions in 2020 was updated from the previous report, as a slight calculation error was identified and corrected.

Alaska

In 2023, an estimated 523 children were adopted in Alaska. This decreased 2.43% from the previous year. In 2023, adoptions from foster care made up 57.36% of total adoptions, while private domestic adoptions made up 42.64%, and intercountry adoptions made up 0%. The total number of adoptions from foster care was 300, which decreased 5.66% from the previous year. The total number of private domestic adoptions was 223, which increased 2.29% from the previous year. The total number of private domestic adoptions comprises 44.00% non-stepparent adoptions and 56.00% stepparent adoptions. Lastly, the total number of intercountry adoptions was zero.

In 2022, an estimated 536 children were adopted in Alaska. This increased 2.68% from the previous year. In 2022, adoptions from foster care made up 59.33% of total adoptions, while private domestic adoptions made up 40.67%, and intercountry adoptions made up 0%. The total number of adoptions from foster care was 318, which decreased 7.29% from the previous year. The total number of private domestic adoptions was 218, which increased 24.57% from the previous year. The total number of adoptions from foster care was 343, which increased 15.88% from the previous year. The total number of private domestic adoptions was 175, which decreased 11.17% from the previous year. The total number of private domestic adoptions comprises 24.22% non-stepparent adoptions and 75.78% stepparent adoptions. Lastly, the total number of intercountry adoptions was four.

Reporting Period

All 2021-2023 data covered the calendar year.

Data Sources

NCFA collected data on the total number of domestic adoptions from the Vital Statistics Annual Reports published by the Alaska Department of Health. These reports divide the adoption numbers by granting authority: State Court, Alaska Native Village Councils (listed as "Cultural"), or Tribal Court. The numbers quoted above refer only to those adoptions granted by the State Court. We chose to use this subset of the adoption data because the numbers collected for 2019 and 2020 counted only court-granted adoptions.

The number of adoptions from foster care came from the Alaska Office of Children's Services (OCS) Statistical Information through

the Department of Family and Community Services.³⁷ The OCS has this same data also available for Alaska's state fiscal year and the federal fiscal year. The number of private adoptions was estimated by subtracting the number of adoptions from foster care from the total number of domestic adoptions.

NCFA received counts for the number of stepparent adoptions from the Administrative Office of the Courts. The Administrative Office of the Courts also provided counts for the total number of adoptions.

Updates to 2019 and 2020 Data

For 2019 and 2020, NCFA received data on the number of adoptions granted and the number of stepparent adoptions from the Alaska court system and data on the number of adoptions from foster care from the Office of Children's Services. Since this data came directly from representatives within the relevant state departments in the previous report, we trust in its validity. However, the reporting period used for 2019 and 2020 data was the state fiscal year, while the data gathered for 2021-2023 cover the calendar year.

In the table, for consistency, and for the sake of better year-to-year comparison, we report the 2019 and 2020 data using the 2021-2023 data sources.

Arizona

In 2023, an estimated 3,143 children were adopted in Arizona. This decreased 20.61% from the previous year. In 2023, adoptions from foster care made up 66.4% of total adoptions, while private domestic adoptions made up 33.25%, and intercountry adoptions made up 0.35%. The total number of adoptions from foster care was 2,087, which decreased 20.8% from the previous year. The total number of private domestic adoptions was 1,045, which decreased 20.29% from the previous year. Lastly, the total number of intercountry adoptions was 11.

In 2022, an estimated 3,959 children were adopted in Arizona. This increased 5.15% from the previous year. In 2022, adoptions from foster care made up 66.56% of total adoptions, while private domestic adoptions made up 33.11%, and intercountry adoptions made up 0.33%. The total number of adoptions from foster care was 2,635, which increased 10.34% from the previous year. The total number of private domestic adoptions was 1,311, which decreased 3.89% from the previous year. Lastly, the total number of intercountry adoptions was 13.

In 2021, an estimated 3,765 children were adopted in Arizona. This decreased 9.82% from the previous year. In 2021, adoptions from foster care made up 63.43% of total adoptions, while private domestic adoptions made up 36.23%, and intercountry adoptions made up 0.35%. The total number of adoptions from foster care was 2,388, which decreased 12.43% from the previous year. The total number of private domestic adoptions was 1,364, which decreased 4.41% from the previous year. Lastly, the total number of intercountry adoptions was 13.



Data on the number of adoptions from foster care was collected from the Department of Children's Services Semi-Annual Reports.³⁸ The number of private adoptions was estimated by subtracting the number of adoptions from foster care from the total number of domestic adoptions.

Updates to 2019 and 2020 Data

NCFA used the same source for adoptions from foster care numbers in this report as in the previous report, i.e., the Department of Children's Services Semi-Annual Reports. As the 2019 and 2020 reports had been updated since the last ABTN, we present the updated counts for adoptions from foster care.

The data source for total adoptions is not the same between this report and the last report. In the last report, the Arizona representatives who we contacted did not provide estimates for the number of total adoptions. CSP STAT reported numbers of outgoing cases in these years, but the research team decided not to use the 2020 data as it was less than the number reported for adoptions from foster care that year. Thus, in the previous report, we used CSP STAT data for the total number of domestic adoptions in 2019 and estimated the total number of domestic adoptions and adoptions from foster care. In the current report, for the 2021–2023 counts, we received from the Bureau of Vital Records exact counts of the number of adoptions completed by the State Office.

Due to data discrepancies and based on the greater confidence we had in the 2021-2023 data, we re-estimated the total number of domestic adoptions for 2019 and 2020. These new estimates are based on applying the average ratio of adoptions from foster care versus domestic adoptions in 2021 through 2023 to the counts for the adoptions from foster care in 2019 and 2020.

Arkansas

In 2023, an estimated 2,189 children were adopted in Arkansas. This increased 1.72% from the previous year. In 2023, adoptions from foster care made up 37.28% of total adoptions, while private domestic adoptions made up 62.63%, and intercountry adoptions made up 0.09%. The total number of adoptions from foster care was 816, which increased 1.24% from the previous year. The total number of private domestic adoptions was 1,371, which increased 2.47% from the previous year. Lastly, the total number of intercountry adoptions was two.

In 2022, an estimated 2,152 children were adopted in Arkansas. This decreased 4.86% from the previous year. In 2022, adoptions from foster care made up 37.45% of total adoptions, while private domestic adoptions made up 62.17%, and intercountry adoptions made up 0.37%. The total number of adoptions from foster care was 806, which decreased 3.13% from the previous year. The total number of private domestic adoptions was 1,338, which decreased 6.17% from the previous year. Lastly, the total number of intercountry adoptions was eight.

In 2021, an estimated 2,262 children were adopted in Arkansas. This increased 8.7% from the previous year. In 2021, adoptions from foster care made up 36.78% of total adoptions, while private domestic adoptions made up 63.04%, and intercountry adoptions made up 0.18%. The total number of adoptions from foster care was 832, which decreased 4.59% from the previous year. The total number of private domestic adoptions was 1,426, which increased 18.73% from the previous year. Lastly, the total number of intercountry adoptions was four.


Reporting Period

All 2021-2023 data covered the state fiscal year.

Data Sources

Data on the total number of domestic adoptions was collected from the Judiciary Statistical Supplement published by the Office of Research and Justice Statistics in the Arkansas Judiciary.³⁹ The data for the number of adoptions from foster

care was collected from the Annual Report Cards published by the Department of Human Services, Division of Children and Family Services.⁴⁰ The number of private adoptions was estimated by subtracting the number of adoptions from foster care from the total number of domestic adoptions.

Updates to 2019 and 2020 Data

In 2019 and 2020, we also collected total adoption data from the Judiciary Statistical Supplement. However, as our data for adoptions from foster care utilized the calendar year and the Judiciary Statistical Supplement organizes data by state fiscal year, we decided to use the outgoing disposition data from the Court Statistics Project instead, since these data are recorded by calendar year.

In the table, for consistency, and for the sake of better yearto-year comparison, we report the 2019 and 2020 data using the 2021-2023 data sources.

California

In 2023, an estimated 10,597 children were adopted in California. This increased 11.23% from the previous year. In 2023, adoptions from foster care made up 59.5% of total adoptions, while private domestic adoptions made up 39.42%, and intercountry adoptions made up 1.09%. The total number of adoptions from foster care was 6,305, which increased 1.14% from the previous year. The total number of private domestic adoptions was 4,177, which increased 32.23% from the previous year. Lastly, the total number of intercountry adoptions was 115, which decreased 14.18% from the previous year.

In 2022, an estimated 9,527 children were adopted in California. This increased 0.25% from the previous year. In 2022, adoptions from foster care made up 65.44% of total adoptions, while private domestic adoptions made up 33.16%, and intercountry adoptions made up 1.41%. The total number of adoptions from foster care was 6,234, which decreased 1.87% from the previous year. The total number of private domestic adoptions was 3,159, which increased 5.51% from the previous year. Lastly, the total number of intercountry adoptions was 134, which decreased 14.1% from the previous year.

In 2021, an estimated 9,503 children were adopted in California. This increased 23.34% from the previous year. In 2021, adoptions from foster care made up 66.85% of total adoptions, while private domestic adoptions made up 31.51%, and intercountry adoptions made up 1.64%. The total number of adoptions from foster care was 6,353, which increased 17.65% from the previous year. The total number of private domestic adoptions was 2,994, which increased 37.66% from the previous year. Lastly, the total number of intercountry adoptions was 156, which increased 20% from the previous year.


Reporting Period

All 2021-2023 data covered the calendar year.

Data Sources

Following the method taken in the previous report, NCFA reached out to each of the state's 58 superior courts requesting data on the total adoptions disposed or finalized in their respective county. We received responses from 46 of the 58 counties. The child population in the responding counties was divided by the child population of California in 2021 to calculate the proportion between the child population in these

counties and the child population of the entire state.⁴¹ This proportion was used to estimate the total number of domestic adoptions in California by dividing the total number of adoptions reported in the responding counties by the calculated proportion.

Data for the number of adoptions from foster care are readily available through the California Child Welfare Indicators Project (CCWIP) housed at UC Berkeley.⁴² NCFA used the "Exits from Foster Care" data from the CCWIP dashboard. An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

The data sources between the previous report and the current report are the same, with the exception of the 2019 and 2020 numbers for total adoptions being based on data received from fewer (36) counties.

Colorado

In 2023, an estimated 2,239 children were adopted in Colorado. This decreased 2.4% from the previous year. In 2023, adoptions from foster care made up 32.25% of total adoptions, while private domestic adoptions made up 65.3%, and intercountry adoptions made up 2.46%. The total number of adoptions from foster care was 722, which decreased 8.49% from the previous year. The total number of private domestic adoptions was 1,462, which decreased 0.81% from the previous year. Lastly, the total number of intercountry adoptions was 55.

In 2022, an estimated 2,294 children were adopted in Colorado. This increased 4.13% from the previous year. In 2022, adoptions from foster care made up 34.39% of total adoptions, while private domestic adoptions made up 64.25%, and intercountry adoptions made up 1.35%. The total number of adoptions from foster care was 789, which decreased 4.25% from the previous year. The total number of private domestic adoptions was 1,474, which increased 10.66% from the previous year. Lastly, the total number of intercountry adoptions was 31.

In 2021, an estimated 2,203 children were adopted in Colorado. This decreased 1.26% from the previous year. In 2021, adoptions from foster care made up 37.4% of total adoptions, while private domestic adoptions made up 60.46%, and intercountry adoptions made up 2.13%. The total number of adoptions from foster care was 824, which decreased 10.53% from the previous year. The total number of private domestic adoptions was 1,332, which increased 5.05% from the previous year. Lastly, the total number of intercountry adoptions was 47.


Reporting Period

All 2021-2023 data covered the state fiscal year.

Data Sources

NCFA collected data on the total number of domestic adoptions from the Colorado Judicial Branch Annual Statistical Reports. The numbers used in this report are based on the number of adoption case filings.⁴³ We referenced the "Permanency Outcomes for Children Served in a Child Welfare Case" dashboard through the Colorado Department of Human Services (DHS) Community Performance Center for data on the

number of adoptions from foster care.⁴⁴ An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

The final 2019 and 2020 data used in the previous report used the CSP incoming case numbers for the total number of adoptions and AFCARS numbers for the number of adoptions from foster care. Consequently, the reporting periods differed between these two categories—calendar year for total number of adoptions and federal fiscal year for public adoptions. It is an improvement in the current report to have the reporting periods between the total adoption numbers and the adoptions from foster care numbers match.

In the table, for consistency, and for the sake of better yearto-year comparison, we report the 2019 and 2020 data using the 2021-2023 data sources. We note that the values reported for the number of adoption case filings are the same between CSP and the Judicial Branch Annual Statistical Reports, so those data points remain the same from the previous report.

Connecticut

In 2023, an estimated 751 children were adopted in Connecticut. This increased 9.64% from the previous year. In 2023, adoptions from foster care made up 65.65% of total adoptions, while private domestic adoptions made up 32.49%, and intercountry adoptions made up 1.86%. The total number of adoptions from foster care was 493, which decreased 7.5% from the previous year. The total number of private domestic adoptions was 244, which increased 69.44% from the previous year. Lastly, the total number of intercountry adoptions was 14.

In 2022, an estimated 685 children were adopted in Connecticut. This decreased 7.68% from the previous year. In 2022, adoptions from foster care made up 77.81% of total adoptions, while private domestic adoptions made up 21.02%, and intercountry adoptions made up 1.17%. The total number of adoptions from foster care was 533, which increased 30.64% from the previous year. The total number of private domestic adoptions was 144, which decreased 55.42% from the previous year. Lastly, the total number of intercountry adoptions was eight.

In 2021, an estimated 742 children were adopted in Connecticut. This increased 59.23% from the previous year. In 2021, adoptions from foster care made up 54.99% of total adoptions, while private domestic adoptions made up 43.53%, and intercountry adoptions made up 1.48%. The total number of adoptions from foster care was 408, which increased 32.9% from the previous year. The total number of private domestic adoptions was 323, which increased 112.5% from the previous year. Lastly, the total number of intercountry adoptions was 11.


Reporting Period

All 2021-2023 data covered the state fiscal year.

Data Sources

NCFA received data on the total number of domestic adoptions from the Connecticut Judicial Branch and the Office of the Probate Court Administrator. Connecticut finalizes adoptions at both the judicial and the probate level, so the sum of the estimates from these two branches was understood to be

the total number of adoptions finalized in the state. The Office of Data Reporting and Evaluation in the Connecticut Department of Children and Families, Bureau of Continuous Quality Improvement, provided the number of adoptions from foster care finalized in the state. An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

The source for the total number of adoptions is the same in the current report as in the last report. NCFA also received data from the courts on the number of private adoptions in 2019 and 2020, and the difference between the total and the number of private adoptions was used as an estimate for the number of adoptions from foster care. For 2021-2023, NCFA used data from the Department of Children and Families for the number of adoptions from foster care and estimated the number of private adoptions.

Delaware

In 2023, an estimated 151 children were adopted in Delaware. This increased 34.26% from the previous year. In 2023, domestic adoptions made up 96.03% of total adoptions, while intercountry adoptions made up 3.97%. Data on adoptions from foster care and private domestic adoptions are not yet available. The total number of intercountry adoptions was six.

In 2022, an estimated 111 children were adopted in Delaware. This decreased 26.49% from the previous year. In 2022, adoptions from foster care made up 53.15% of total adoptions, while private domestic adoptions made up 44.14%, and intercountry adoptions made up 2.7%. The total number of adoptions from foster care was 59. The total number of private domestic adoptions was 49. Lastly, the total number of intercountry adoptions was three.

In 2021, an estimated 151 children were adopted in Delaware. This decreased 4.43% from the previous year. In 2021, adoptions from foster care made up 68.21% of total adoptions, while private domestic adoptions made up 25.17%, and intercountry adoptions made up 6.62%. The total number of adoptions from foster care was 103. The total number of private domestic adoptions was 38. Lastly, the total number of intercountry adoptions was 10.

Reporting Period

All 2021-2023 data covered the state fiscal year.


Data Sources

The Family Court Annual Reports published by the Administrative Office of the Courts provided estimates for the total number of adoptions in the state based on the number of adoption case dispositions.⁴⁵ Numbers of adoptions from foster care completed annually were drawn from the Annual Progress and Services Report from the Department of Services for Children, Youth & Their Families (DSCYF).⁴⁶ An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

The source for the total number of adoptions is the same in the current report as in the previous report, but the source for the number of adoptions from foster care is different. In the previous report, we received data for the number of adoptions from foster care by calendar year from the Adoption Program of DSCYF, Division of Family Services. NCFA decided to use the federal fiscal year–based AFCARS data instead, in order to better match the reporting period of the total adoption data. It is an improvement in the current report to have the reporting periods between the total adoption numbers and the adoptions from foster care numbers match.

In the table, for consistency, and for the sake of better yearto-year comparison, we report the 2019 and 2020 data using the 2021-2023 data sources.

District of Columbia

In 2023, an estimated 185 children were adopted in the District of Columbia. This increased 5.11% from the previous year. In 2023, adoptions from foster care made up 35.14% of total adoptions, while private domestic adoptions made up 61.62%, and intercountry adoptions made up 3.24%. The total number of adoptions from foster care was 65. The total number of private domestic adoptions was 114. Lastly, the total number of intercountry adoptions was six.

In 2022, an estimated 176 children were adopted in the District of Columbia. This decreased 17.37% from the previous year. In 2022, adoptions from foster care made up 57.95% of total adoptions, while private domestic adoptions made up 38.64%, and intercountry adoptions made up 3.41%. The total number of adoptions from foster care was 102. The total number of private domestic adoptions was 68. Lastly, the total number of intercountry adoptions was six.

In 2021, an estimated 213 children were adopted in the District of Columbia. This increased 18.99% from the previous year. In 2021, adoptions from foster care made up 52.58% of total adoptions, while private domestic adoptions made up 45.07%, and intercountry adoptions made up 2.35%. The total number of adoptions from foster care was 112. The total number of private domestic adoptions was 96. Lastly, the total number of intercountry adoptions was five.


Reporting Period

Data on the total number of domestic adoptions covered the calendar year, while data on the number of adoptions from foster care covered the federal fiscal year. As the number of private adoptions was taken as the difference between the total adoptions and the adoptions from foster care, the reporting period for private adoptions is mixed.

Data Sources

For an approximation for the total number of domestic adoptions, we referenced the DC Courts Annual Reports and Family Court Annual Reports, which tabulated the number of adoption case dispositions each calendar year.⁴⁷ For the number of

adoptions from foster care, we used the Child & Family Services Agency (CSFA) Data Dashboard⁴⁸ and AFCARS for data on the number of adoptions from foster care. An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.⁴⁹

Updates to 2019 and 2020 Data

In the previous report, the data on the total number of domestic adoptions and the number of private adoptions, in addition to a few other data points, was provided by the Office of General Counsel. This source also provided data on the number of adoptions from foster care for 2019, but not 2020, so the value for 2020 was imputed from AFCARS.

Florida

For 2023, a majority of data are not yet available. The total number of adoptions from foster care was 3,710, which decreased 2.37% from the previous year. The total number of intercountry adoptions was 75.

In 2022, an estimated 6,311 children were adopted in Florida. This decreased 8.11% from the previous year. In 2022, adoptions from foster care made up 60.21% of total adoptions, while private domestic adoptions made up 38.88%, and intercountry adoptions made up 0.9%. The total number of adoptions from foster care was 3,800, which decreased 3.43% from the previous year. The total number of private domestic adoptions was 2,454, which decreased 14.02% from the previous year. Lastly, the total number of intercountry adoptions was 57.

In 2021, an estimated 6,868 children were adopted in Florida. This increased 15.58% from the previous year. In 2021, adoptions from foster care made up 57.29% of total adoptions, while private domestic adoptions made up 41.56%, and intercountry adoptions made up 1.15%. The total number of adoptions from foster care was 3,935, which decreased 1.5% from the previous year. The total number of private domestic adoptions was 2,854, which increased 53.11% from the previous year. Lastly, the total number of intercountry adoptions was 79.

Reporting Period

All 2021-2023 data covered the calendar year.


Data Sources

NCFA relied on the comprehensive report "Adoptions of Children in Florida: An Overview," compiled and published by the Office of Program Policy Analysis and Government Accountability (OPPAGA) in the Florida Legislature in 2023, for data on the total number of domestic adoptions and the number of adoptions from foster care.⁵⁰

OPPAGA used data from the Department of Children and Families (DCF), the U.S. Department of State, the Florida Office of the State Courts Administrator, and the Florida Department of Health (DOH) going back about a decade. Exhibit 2 provided data from DCF on the annual number of adoptions from foster care and Exhibit 5 provided data from the Bureau of Vital Statistics on the annual number of adoptions of Florida-born minors. were used for the total adoptions and adoptions from foster care numbers in this report.⁵¹

An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

Absent the equivalent of an OPPAGA report or easily accessibly Bureau of Vital Statistics data, NCFA estimated the total number of domestic adoptions in Florida in 2019 and 2020 by contacting representatives within the state's 20 judicial courts and 67 counties to request counts of domestic adoptions completed in each county. A few of the judicial courts were able to provide data for all of the counties in their jurisdiction, while several others redirected the research team to the individual county clerks of court. In the end, NCFA had data for 32 of the 67 counties. The OPPAGA report removed the need to follow this process the current report.

The research team compared the 2019 and 2020 estimates for the number of total adoptions (which were estimates based on data from 32 counties) to the numbers reported for 2019 and 2020 in the OPPAGA report (which were based on Bureau of Vital Statistics records) and determined that the method used in the previous report yielded a reliable proxy for the actual count.

Georgia

In 2023, an estimated 2,576 children were adopted in Georgia. This decreased 12.56% from the previous year. In 2023, adoptions from foster care made up 49.77% of total adoptions, while private domestic adoptions made up 48.1%, and intercountry adoptions made up 2.14%. The total number of adoptions from foster care was 1,282, which increased 3.47% from the previous year. The total number of private domestic adoptions was 1,239, which decreased 25.05% from the previous year. Lastly, the total number of intercountry adoptions was 55.

In 2022, an estimated 2,946 children were adopted in Georgia. This increased 3.12% from the previous year. In 2022, adoptions from foster care made up 42.06% of total adoptions, while private domestic adoptions made up 56.11%, and intercountry adoptions made up 1.83%. The total number of adoptions from foster care was 1,239, which decreased 4.4% from the previous year. The total number of private domestic adoptions was 1,653, which increased 10.87% from the previous year. Lastly, the total number of intercountry adoptions was 54.

In 2021, an estimated 2,857 children were adopted in Georgia. This decreased 1.45% from the previous year. In 2021, adoptions from foster care made up 45.36% of total adoptions, while private domestic adoptions made up 52.19%, and intercountry adoptions made up 2.45%. The total number of adoptions from foster care was 1,296, which decreased 18.23% from the previous year. The total number of private domestic adoptions was 1,491, which increased 17.68% from the previous year. Lastly, the total number of intercountry adoptions was 70.

Reporting Period


Data on the total number of domestic adoptions covered the calendar year, while data on the number of adoptions from foster care covered the federal fiscal year. As the number of private adoptions was taken as the difference between the total adoptions and the adoptions from foster care, the reporting period for private adoptions is mixed.

Data Sources

NCFA gathered an estimation for the total number of domestic adoptions completed each year from the Superior Court Case Data released by the Georgia Administrative Office of the Courts, which reports the number of case dispositions.⁵² There

were two potential data sources for the number of adoptions from foster care: AFCARS, which is based on the federal fiscal year; and the child welfare data dashboard from the Georgia Department of Human Services (DHS), which is based on the state fiscal year.⁵³ We opted to use the AFCARS data since the federal fiscal year better aligns with the calendar year than the state fiscal year. An estimation for the number of private adoptions was obtained by taking the difference between total adoptions and adoptions from foster care.

Updates to 2019 and 2020 Data

The reporting period for the total number of adoptions differed from the reporting period for the number of adoptions from foster care in the previous report for 2019 and 2020, as well as in the current report. Previously, NCFA used the number of outgoing adoption cases from CSP STAT, which follows the calendar year, to approximate the total number of adoptions. There is good agreement between the outgoing cases reported by CSP STAT for 2022 and the number of case dispositions reported by the Georgia Administrative Office of the Courts for 2022, so we are confident that the difference in sources between the previous report and the current report is not deleterious for analyses.

The sources for the number of adoptions from foster care are the same between the two reports.

Hawaii

In 2023, an estimated 412 children were adopted in Hawaii. This decreased 0.24% from the previous year. In 2023, adoptions from foster care made up 50.24% of total adoptions, while private domestic adoptions made up 48.54%, and intercountry adoptions made up 1.21%. The total number of adoptions from foster care was 207, which decreased 1.9% from the previous year. The total number of private domestic adoptions was 200, which increased 0.5% from the previous year. Lastly, the total number of intercountry adoptions was five.

In 2022, an estimated 413 children were adopted in Hawaii. This increased 31.95% from the previous year. In 2022, adoptions from foster care made up 51.09% of total adoptions, while private domestic adoptions made up 48.18%, and intercountry adoptions made up 0.73%. The total number of adoptions from foster care was 211, which decreased 14.92% from the previous year. The total number of private domestic adoptions was 199, which increased 249.12% from the previous year. Lastly, the total number of intercountry adoptions was three.

In 2021, an estimated 313 children were adopted in Hawaii. This increased 5.74% from the previous year. In 2021, adoptions from foster care made up 79.23% of total adoptions, while private domestic adoptions made up 18.21%, and intercountry adoptions made up 2.56%. The total number of adoptions from foster care was 248, which increased 16.98% from the previous year. The total number of private domestic adoptions was 57, which decreased 29.63% from the previous year. Lastly, the total number of intercountry adoptions was eight.


Reporting Period

All 2021-2023 data covered the state fiscal year.

Data Sources

NCFA obtained approximations for the total number of adoptions from the Statistical Supplements of the Hawaii State Judiciary Annual Reports.⁵⁴ Table 17 of each fiscal year's Statistical Supplement sums the adoption case outcomes across all state family courts, and the total of adoption cases closed each year was taken as the sum of the "Granted" and "Not

Specified" columns of the "Adoption Proceedings" row. Data on the number of adoptions from foster care were drawn from the Department of Human Services (DHS) Databooks released by the Audit, Quality Control & Research Office.⁵⁵ An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

The 2019 and 2020 numbers used for Hawaii in the previous report were based on outgoing case data from CSP STAT and adoption data from AFCARS. NCFA also referenced the DHS Datebooks for adoptions from foster care data but decided to use AFCARS data instead because we had not accessed the Judiciary Statistical Supplements then and the reporting period of the AFCARS data better aligned with the reporting period of the CSP STAT data. The current report, by the choice of data sources, has matched the reporting periods between total and public adoptions.

In the table, for consistency, and for the sake of better yearto-year comparison, we report the 2019 and 2020 data using the 2021-2023 data sources.

Idaho

In 2023, an estimated 718 children were adopted in Idaho. This decreased 13.81% from the previous year. In 2023, adoptions from foster care made up 36.21% of total adoptions, while private domestic adoptions made up 62.4%, and intercountry adoptions made up 1.39%. The total number of adoptions from foster care was 260, which decreased 15.86% from the previous year. The total number of private domestic adoptions was 448, which decreased 12.84% from the previous year. Lastly, the total number of inter-country adoptions was 10.

In 2022, an estimated 833 children were adopted in Idaho. This decreased 5.02% from the previous year. In 2022, adoptions from foster care made up 37.09% of total adoptions, while private domestic adoptions made up 61.7%, and intercountry adoptions made up 1.2%. The total number of adoptions from foster care was 309, which decreased 20.36% from the previous year. The total number of private domestic adoptions was 514, which increased 7.98% from the previous year. Lastly, the total number of intercountry adoptions was 10.

In 2021, an estimated 877 children were adopted in Idaho. This increased 6.3% from the previous year. In 2021, adoptions from foster care made up 44.24% of total adoptions, while private domestic adoptions made up 54.28%, and intercountry adoptions made up 1.48%. The total number of adoptions from foster care was 388, which increased 13.45% from the previous year. The total number of private domestic adoptions was 476, which increased 1.71% from the previous year. Lastly, the total number of intercountry adoptions was 13.

Reporting Period

All 2021-2023 data covered the state fiscal year.

Data Sources


NCFA approximated the total number of domestic adoptions completed annually by summing up the number of case filings for "Adoption" and "Adoption and Termination of Parental Rights" from the Case and Charge Data Dashboard provided through the State of Idaho Judicial Branch.⁵⁶ Since this sum includes Termination of Parental Rights (TPR) cases, it may be an overestimation of the total number of adoptions. Comparison of the data with the number of incoming adoption cases or number of outgoing adoption cases given by CSP STAT provides some assurance that this method of approximating the total is consistent with other reports.

We gathered counts of adoptions from foster care from the Facts, Figures and Trends documents published by the Idaho Department of Health & Welfare (DHW).⁵⁷ The Annual Legislative Foster Care

Report from DHW's Division of Family and Community Services also tabulates this data,⁵⁸ and the counts reported are within ten of those provided by Facts, Figures and Trends. We opted to use the Facts, Figures and Trends data rather than the Annual Legislative Foster Care Report data because the former has a longer publication history.

An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

For total number of adoptions in 2019 and 2020, NCFA referred to the outgoing adoption case data from CSP STAT, and, for number of adoptions from foster care, the adoption data from AFCARS. The current report relies on reports published by Idaho state government offices. The alternative sources referenced in this report followed the same reporting period, while the previous report used the calendar year (CY) for the total adoption numbers and the federal fiscal year for the adoptions from foster care numbers.

In the table, for consistency, and for the sake of better year-toyear comparison, we report the 2019 and 2020 data using the 2021-2023 data sources. Data for state fiscal year (SFY) 2019 are not available through the Case and Charge Data Dashboard, but data for CY 2019 are available, so we used it for the total adoption data point in 2019.

Illinois

For 2023, a majority of data are not yet available. The total number of adoptions from foster care was 2,160, which increased 21.42% from the previous year. The total number of intercountry adoptions was 66.

In 2022, an estimated 2,932 children were adopted in Illinois. This increased 13.42% from the previous year. In 2022, adoptions from foster care made up 60.68% of total adoptions, while private domestic adoptions made up 37.41%, and intercountry adoptions made up 1.91%. The total number of adoptions from foster care was 1,779, which increased 5.96% from the previous year. The total number of private domestic adoptions was 1,097, which increased 33.29% from the previous year. Lastly, the total number of intercountry adoptions was 56.

In 2021, an estimated 2,585 children were adopted in Illinois. This increased 30.42% from the previous year. In 2021, adoptions from foster care made up 64.95% of total adoptions, while private domestic adoptions made up 31.84%, and intercountry adoptions made up 3.21%. The total number of adoptions from foster care was 1,679, which increased 10.32% from the previous year. The total number of private domestic adoptions was 823, which increased 116.01% from the previous year. Lastly, the total number of intercountry adoptions was 83.



Indiana

In 2023, an estimated 4,046 children were adopted in Indiana. This decreased 8.69% from the previous year. In 2023, adoptions from foster care made up 50.47% of total adoptions, while private domestic adoptions made up 48.89%, and intercountry adoptions made up 0.64%. The total number of adoptions from foster care was 2,042, which decreased 13.62% from the previous year. The total number of private domestic adoptions was 1,978, which decreased 1.35% from the previous year. Lastly, the total number of intercountry adoptions was 26.

In 2022, an estimated 4,431 children were adopted in Indiana. This decreased 7.73% from the previous year. In 2022, adoptions from foster care made up 53.35% of total adoptions, while private domestic adoptions made up 45.25%, and intercountry adoptions made up 1.4%. The total number of adoptions from foster care was 2,364, which increased 9.9% from the previous year. The total number of private domestic adoptions was 2,005, which decreased 22.83% from the previous year. Lastly, the total number of intercountry adoptions was 62.

In 2021, an estimated 4,802 children were adopted in Indiana. This increased 1.05% from the previous year. In 2021, adoptions from foster care made up 44.79% of total adoptions, while private domestic adoptions made up 54.1%, and intercountry adoptions made up 1.1%. 

The total number of adoptions from foster care was 939, which decreased 2.69% from the previous year. 



For 2023, a majority of data are not yet available. The total number of intercountry adoptions was 21.

In 2022, an estimated 2,471 children were adopted in Kentucky. This decreased 3.14% from the previous year. In 2022, adoptions from foster care made up 48.89% of total adoptions, while private domestic adoptions made up 50.3%, and intercountry adoptions made up 0.81%. The total number of adoptions from foster care was 1,208, which increased 4.59% from the previous year. The total number of private domestic adoptions was 1,243, which decreased 9.27% from the previous year. 

Louisiana

In 2023, an estimated 1,236 children were adopted in Louisiana. This decreased 10.04% from the previous year. In 2023, domestic adoptions made up 99.84% of total adoptions, while intercountry adoptions made up 0.16%. Data on adoptions from foster care and private domestic adoptions are not yet available. The total number of intercountry adoptions was two.

In 2022, an estimated 1,374 children were adopted in Louisiana. This decreased 10.25% from the previous year. In 2022, adoptions from foster care made up 50.95% of total adoptions, while private domestic adoptions made up 48.25%, and intercountry adoptions made up 0.8%. The total number of adoptions from foster care was 700, which increased 14.38% from the previous year. The total number of private domestic adoptions was 663, which decreased 27.06% from the previous year. Lastly, the total number of intercountry adoptions was 11.

In 2021, an estimated 1,531 children were adopted in Louisiana. This increased 10.46% from the previous year. In 2021, adoptions from foster care made up 39.97% of total adoptions, while private domestic adoptions made up 59.37%, and intercountry adoptions made up 0.65%. The total number of adoptions from foster care was 612, which decreased 19.15% from the previous year. The total number of private domestic adoptions was 909, which increased 45.91% from the previous year. Lastly, the total number of intercountry adoptions was 10.


Reporting Period

Data on the total number of domestic adoptions covered the calendar year, while data on the number of adoptions from foster care covered the state fiscal year. As the number of private adoptions was taken as the difference between the total adoptions and the adoptions from foster care, the reporting period for private adoptions is mixed.

Data Sources

NCFA approximated the total number of domestic adoptions from the number of incoming adoption cases reported by CSP STAT. We used the number of adoptions provided in fact

Maine

In 2023, an estimated 514 children were adopted in Maine. This decreased 21.77% from the previous year. In 2023, adoptions from foster care made up 69.07% of total adoptions, while private domestic adoptions made up 30.16%, and intercountry adoptions made up 0.78%. The total number of adoptions from foster care was 355, which decreased 12.56% from the previous year. The total number of private domestic adoptions was 155, which decreased 35.95% from the previous year. Lastly, the total number of intercountry adoptions was four.


In 2022, an estimated 657 children were adopted in Maine. This increased 8.96% from the previous year. In 2022, adoptions from foster care made up 61.8% of total adoptions, while private domestic adoptions made up 36.83%, and intercountry adoptions made up 1.37%. The total number of adoptions from foster care was 406, which increased 5.73% from the previous year. Maryland

In 2023, an estimated 1,133 children were adopted in Maryland. This increased 15.73% from the previous year. In 2023, adoptions from foster care made up 28.16% of total adoptions, while private domestic adoptions made up 67.87%, and intercountry adoptions made up 3.97%. The total number of adoptions from foster care was 319, which increased 37.5% from the previous year. The total number of private domestic adoptions was 769, which increased 9.23% from the previous year. Lastly, the total number of intercountry adoptions was 45.

In 2022, an estimated 979 children were adopted in Maryland. This increased 3.82% from the previous year. In 2022, adoptions from foster care made up 23.7% of total adoptions, while private domestic adoptions made up 71.91%, and intercountry adoptions made up 4.39%. The total number of adoptions from foster care was 232, which increased 7.91% from the previous year. The total number of private domestic adoptions was 704, which increased 6.99% from the previous year. Lastly, the total number of intercountry adoptions was 43.

In 2021, an estimated 943 children were adopted in Maryland. This increased 18.77% from the previous year. In 2021, adoptions from foster care made up 22.8% of total adoptions, while private domestic adoptions made up 69.78%, and intercountry adoptions made up 7.42%. The total number of adoptions from foster care was 215, which increased 27.22% from the previous year. The total number of private domestic adoptions was 658, which increased 15.24% from the previous year. Lastly, the total number of intercountry adoptions was 70.

Reporting Period

All 2021-2023 data covered the calendar year.



NCFA originally assessed the Statistical Abstracts of the Maryland Judiciary Annual Report for the total number of adoptions.⁶⁷ However, the adoption case filing and disposition data in these reports covered both civil court cases and juvenile court cases, and the former combined adoption with guardianship. Thus, while the number of adoption case filings and dispositions from the juvenile side could be determined, they could not be parsed from the adoption/guardianship case filings and dispositions from the civil side. We opted to use the number of outgoing adoption cases reported by CSP STAT instead.

For the number of adoptions from foster care, we summed "OOH Placements-Exits: Adoption" from the Monthly Child Welfare

Reports published by the Department of Human Services.⁶⁸ An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

We suspect that adoption numbers in the previous report are greatly underestimated. The total number of adoptions quoted had been based on the juvenile adoption case data reported in the Statistical Abstracts of the Maryland Judiciary Annual Report. It had not considered the civil adoption/guardianship cases and, based on the division of adoption cases in the Maryland court system, likely only counted the number of adoptions from foster care.

The number of adoptions from foster care reported for 2019 and 2020 had been based on the annual reports of the Citizens Review Board for Children.⁶⁹ However, these do not tabulate all the adoptions from foster care completed in Maryland, but only a subset that the Board reviewed and commented on for that year.

These interpretations better accord with adoption data reported for Maryland in 2014. 70

Massachusetts

In 2023, an estimated 1,754 children were adopted in Massachusetts. This increased 8.54% from the previous year. In 2023, adoptions from foster care made up 44.75% of total adoptions, while private domestic adoptions made up 54.62%, and intercountry adoptions made up 0.63%. The total number of adoptions from foster care was 785, which decreased 5.42% from the previous year. The total number of private domestic adoptions was 958, which increased 26.89% from the previous year. Lastly, the total number of intercountry adoptions was 11.

In 2022, an estimated 1,616 children were adopted in Massachusetts. This increased 10.61% from the previous year. In 2022, adoptions from foster care made up 51.36% of total adoptions, while private domestic adoptions made up 46.72%, and intercountry adoptions made up 1.92%. The total number of adoptions from foster care was 830, which increased 15.28% from the previous year. The total number of private domestic adoptions was 755, which increased 6.94% from the previous year. Lastly, the total number of intercountry adoptions was 31.

In 2021, an estimated 1,461 children were adopted in Massachusetts. This decreased 2.99% from the previous year. In 2021, adoptions from foster care made up 49.28% of total adoptions, while private domestic adoptions made up 48.32%, and intercountry adoptions made up 2.4%. The total number of adoptions from foster care was 720, which decreased 13.15% from the previous year. The total number of private domestic adoptions was 706, which increased 9.29% from the previous year. Lastly, the total number of intercountry adoptions was 35.



In 2023, an estimated 2,745 children were adopted in Michigan. This decreased 5.25% from the previous year. In 2023, adoptions from foster care made up 58.65% of total adoptions, while private domestic adoptions made up 40.04%, and intercountry adoptions made up 1.31%. The total number of adoptions from foster care was 1,610, which decreased 4.05% from the previous year. The total number of private domestic adoptions was 1,099, which decreased 7.34% from the previous year. Lastly, the total number of intercountry adoptions was 36.



In 2023, an estimated 1,644 children were adopted in Minnesota. This increased 0.06% from the previous year. In 2023, domestic adoptions made up 98.24% of total adoptions, while intercountry adoptions made up 1.76%. Data on adoptions from foster care and private domestic adoptions are not yet available. The total number of intercountry adoptions was 29.

In 2022, an estimated 1,643 children were adopted in Minnesota. This increased 9.46% from the previous year. 

The total number of adoptions from foster care was 637, which decreased 0.78% from the previous year. The total number of private domestic adoptions was 962, which increased 19.06% from the previous year. Lastly, the total number of intercountry adoptions was 8.

In 2022, an estimated 1,466 children were adopted in Mississippi. This increased 8.19% from the previous year. In 2022, adoptions from foster care made up 43.79% of total adoptions, while private domestic adoptions made up 55.12%, and intercountry adoptions made up 1.09%. The total number of adoptions from foster care was 642, which increased 20.9% from the previous year. The total number of private domestic adoptions was 808, which decreased 1.1% from the previous year. Lastly, the total number of intercountry adoptions was 16.

In 2021, an estimated 1,355 children were adopted in Mississippi. This decreased 7.7% from the previous year. 

As explained in the previous report: "The number of private adoptions for each year was divided by the number of adoptions from foster care to obtain a proportion for each year. The proportions were averaged to obtain an average proportion across these four discontinuous years. The number of adoptions from foster care, which was obtained from AFCARS data, was multiplied by this average proportion to estimate the total number of domestic adoptions."

Due to data discrepancies and based on the greater confidence we had in the 2021-2023 data, we re-estimated the total number of domestic adoptions for 2019 and 2020. These new estimates are based on applying the average ratio of adoptions from foster care versus domestic adoptions in 2021 through 2023 to the counts for the adoptions from foster care in 2019 and 2020.

In 2023, an estimated 2,683 children were adopted in Missouri. This decreased 10.18% from the previous year. In 2023, adoptions from foster care made up 59.04% of total adoptions, while private domestic adoptions made up 39.84%, and intercountry adoptions made up 1.12%. The total number of adoptions from foster care was 1,584, which increased 0.06% from the previous year. The total number of private domestic adoptions was 1,069, which decreased 22.25% from the previous year. The total number of private domestic adoptions comprises 30.31% non-stepparent adoptions and 69.69% stepparent adoptions. Lastly, the total number of intercountry adoptions was 30.

In 2022, an estimated 2,987 children were adopted in Missouri. This decreased 1.42% from the previous year. In 2022, adoptions from foster care made up 53% of total adoptions, while private domestic adoptions made up 46.03%, and intercountry adoptions made up 0.97%. The total number of adoptions from foster care was 1,520, which decreased 13.54% from the previous year. The total number of private domestic adoptions was 1,479, which increased 24.08% from the previous year. The total number of private domestic adoptions comprises 35.09% non-stepparent adoptions and 64.91% stepparent adoptions. Lastly, the total number of intercountry adoptions was 31.

Reporting Period

All 2021–2023 data covered the state fiscal year.

Data Sources

NCFA received data on the number of adoption case filings and the number of stepparent adoption case filings from the Administrative Services Division of the Office of State Courts Administrator (OSCA) through an OSCA Help Desk Request, which we used to approximate the total number of domestic adoptions. The data was separated between juvenile and adult adoptions; we use only the counts of juvenile adoptions in this report. The numbers of adoptions from foster care were taken from the Missouri Department of Social Services, Children's Division, Children's Services Management April 2024 report, which tabulates the adoptions finalized by fiscal year (FY) from FY 2019 to FY 2024.⁷⁸ An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

NCFA used the number of outgoing adoption cases reported by CSP STAT as an approximation of the total number of domestic adoptions in Missouri in 2019 and 2020. We collected data from the Children's Services Management December 2020 Report for the number of adoptions from foster care but used the federal fiscal year-based AFCARS data instead since its reporting period better aligned with the calendar year-based CSP STAT data. It is an improvement in the current report to have the reporting periods between the total adoption numbers and the adoptions from foster care numbers match.

In the table, for consistency, and for the sake of better year-to-year comparison, we report the 2019 and 2020 adoptions from foster care data using the 2021-2023 data sources.

In 2023, an estimated 628 children were adopted in Montana. This decreased 6.55% from the previous year. In 2023, adoptions from foster care made up 27.23% of total adoptions, while private domestic adoptions made up 71.34%, and intercountry adoptions made up 1.43%. The total number of adoptions from foster care was 171, which decreased 32.41% from the previous year. The total number of private domestic adoptions was 448, which increased 8.74% from the previous year. Lastly, the total number of intercountry adoptions was nine.

In 2022, an estimated 672 children were adopted in Montana. This decreased 14.5% from the previous year. 

Court case filings by major case category.⁷⁹ We received data on the number of adoptions from foster care from the Child and Family Services Division (CFSD) of the Montana Department of Public Health and Human Services. An estimation for the number of private adoptions was obtained by taking the difference between total and public adoptions.

Updates to 2019 and 2020 Data

In the previous report, NCFA received data on the total number of domestic adoptions and the number of public, private, and stepparent adoptions from CFSD, but the figures were based on Interstate Compact on the Placement of Children (ICPC) placements only. Thus, the 2019 and 2020 data were based on the number of incoming adoption cases reported by CSP and the number of adoptions from foster care reported in AFCARS.

Nebraska

In 2023, an estimated 737 children were adopted in Nebraska. This decreased 10.45% from the previous year. In 2023, adoptions from foster care made up 55.77% of total adoptions, while private domestic adoptions made up 43.28%, and intercountry adoptions made up 0.95%. The total number of adoptions from foster care was 411, which increased 12.91% from the previous year. The total number of private domestic adoptions was 319, which decreased 27.83% from the previous year. Lastly, the total number of intercountry adoptions was seven.

In 2022, an estimated 823 children were adopted in Nebraska. This decreased 4.08% from the previous year. In 2022, adoptions from foster care made up 44.23% of total adoptions, while private domestic adoptions made up 53.71%, and intercountry adoptions made up 2.07%. The total number of adoptions from foster care was 364, which decreased 10.34% from the previous year. The total number of private domestic adoptions was 442, which decreased 0.67% from the previous year. Lastly, the total number of intercountry adoptions was 17.

In 2021, an estimated 858 children were adopted in Nebraska. This increased 17.86% from the previous year. In 2021, adoptions from foster care made up 47.32% of total adoptions, while private domestic adoptions made up 51.86%, and intercountry adoptions made up 0.82%. The total number of adoptions from foster care was 406, which decreased 15.24% from the previous year. The total number of private domestic adoptions was 445, which increased 88.56% from the previous year. Lastly, the total number of intercountry adoptions was seven.


Reporting Period

Updates to 2019 and 2020 Data

In the previous report, NCFA received data on the total number of domestic adoptions in a combined response from Department of Health and Human Services (DHHS) and the Nebraska Judicial Branch and data on the number of adoptions from foster care from DHHS. We also referenced the filing data of the County Court Annual Caseload Reports.⁸¹ We used the DHHS-provided data for the number of adoptions from foster care. However, the research team decided to use the numbers of adoption case dispositions reported by CSP for 2019 and 2020 instead of the DHHS/Court data due to the tendency of incoming case data to overestimate adoption finalization numbers.

In the table, for consistency, and for the sake of better yearto-year comparison, we report the 2019 and 2020 data using the 2021-2023 data sources.

In 2023, an estimated 1,173 children were adopted in Nevada. This decreased 4.01% from the previous year. In 2023, adoptions from foster care made up 57.29% of total adoptions, while private domestic adoptions made up 42.54%, and intercountry adoptions made up 0.17%. The total number of adoptions from foster care was 672, which decreased 11.46% from the previous year. The total number of private domestic adoptions was 499, which increased 9.91% from the previous was two.

In 2022, an estimated 1,222 children were adopted in Nevada. This decreased 1.93% from the previous year. In 2022, adoptions from foster care made up 62.11% of total adoptions, while private domestic adoptions made up 37.15%, and intercountry adoptions made up 0.74%. The total number of adoptions from foster care was 759, which increased 1.47% from the previous year. The total number of private domestic adoptions was 454, which decreased 7.16% from the previous year. Lastly, the total number of intercountry adoptions was nine.







The total number of private domestic adoptions was 221, which decreased 28.71% from the previous year. Lastly, the total number of intercountry adoptions was 11.



In 2023, an estimated 3,960 children were adopted in New York. This increased 13.92% from the previous year. In 2023, adoptions from foster care made up 56.11% of total adoptions, while private domestic adoptions made up 42.02%, and intercountry adoptions made up 1.87%. The total number of adoptions from foster care was 2,222, which increased 11.32% from the previous year. The total number of private domestic adoptions was 1,664, which increased 18.77% from the previous year. Lastly, the total number of intercountry adoptions was 74.









In 2023, an estimated 249 children were adopted in Rhode Island. This decreased 19.68% from the previous year. In 2023, adoptions from foster care made up 55.82% of total adoptions, while private domestic adoptions made up 43.37%, and intercountry adoptions made up 0.8%. The total number of adoptions from foster care was 139, which decreased 41.1% from the previous year. The total number of private domestic adoptions was 108 and the total number of intercountry adoptions was two.

In 2022, an estimated 310 children were adopted in Rhode Island. This increased 9.15% from the previous year. In 2022, adoptions from foster care made up 76.13% of total adoptions, while private domestic adoptions made up 23.55%, and intercountry adoptions made up 0.32%. The total number of adoptions from foster care was 236, which decreased 5.6% from the previous year. The total number of private domestic adoptions was 73 and the total number of intercountry adoptions was one.











In 2021, adoptions from foster care made up 30.6% of total adoptions, while private domestic adoptions made up 68.48%, and intercountry adoptions made up 0.92%. The total number of adoptions from foster care was 533, which increased 8.55% from the previous year. The total number of private domestic adoptions was 1,193, which increased 8.16% from the previous year. Lastly, the total number of intercountry adoptions was 16.

Reporting Period

Data on the total number of domestic adoptions covered the calendar year, while data on the number of adoptions from foster care covered the federal fiscal year. As the number of private adoptions was taken as the difference between the total adoptions and the adoptions from foster care, the reporting period for private adoptions is mixed.

Updates to 2019 and 2020 Data

Vermont

For 2023, a majority of data are not yet available. The total number of intercountry adoptions was four.

In 2022, an estimated 272 children were adopted in Vermont. This increased 0.74% from the previous year. In 2022, adoptions from foster care made up 69.12% of total adoptions, while private domestic adoptions made up 30.51%, and intercountry adoptions made up 0.37%. The total number of adoptions from foster care was 188, which decreased 7.84% from the previous year. The total number of private domestic adoptions was 83 and the total number of intercountry adoptions was one.

In 2021, an estimated 270 children were adopted in Vermont. This decreased 22.41% from the previous year. In 2021, adoptions from foster care made up 75.56% of total adoptions, while private domestic adoptions made up 22.96%, and intercountry adoptions made up 1.48%. The total number of adoptions from foster care was 204, which decreased 22.43% from the previous year. The total number of private domestic adoptions was 62 and the total number of intercountry adoptions was four.



Data Sources

Data on the total domestic, public, and private adoptions were all drawn from Appendix I – Statewide Data of the Annual Statistical Report published by the Vermont Judiciary.¹⁰³ These reports note the number of case filings for "Adoption – Adult," "Adoption – Conversion," "Adoption – Minor – Agency," and "Adoption – Minor – Private" separately. Updates to 2019 and 2020 Data

In the previous report, NCFA used the number of incoming cases reported by CSP for the total number of adoptions and the number of adoptions reported by AFCARS for the number of adoptions from foster care. The number of private adoptions was estimated by taking the difference between total and public adoptions. Due to the choice of sources, the data for Vermont in 2019 and 2020 had reporting period discrepancies that we have corrected in the current report by using sources that align with a common reporting period (state fiscal year).

We also previously received 2019 and 2020 data from Lund, a non-profit organization, and the Department of Children and Families, but the research team opted to not use these numbers in the previous report due to perceived discrepancies with data collected from 2014.¹⁰⁴ Reference to the 2019 and 2020 statistical reports from the Vermont Judiciary suggests that the total number of adoptions stated in the previous report are based on a summation of both juvenile and adult adoptions in Vermont.

In 2023, an estimated 3,511 children were adopted in Virginia. This decreased 16% from the previous year. In 2023, adoptions from foster care made up 21.62% of total adoptions, while private domestic adoptions made up 77.39%, and intercountry adoptions made up 1%. The total number of adoptions from foster care was 759, which decreased 16.41% from the previous year. The total number of private domestic adoptions was 2,717, which decreased 15.31% from the previous year. The total number of private domestic adoptions comprises 49.54% non-stepparent adoptions and 50.46% stepparent adoptions. Lastly, the total number of intercountry adoptions was 35.


In 2022, an estimated 4,180 children were adopted in Virginia. This increased 6.17% from the previous year. Washington

In 2023, an estimated 1,557 children were adopted in Washington. This increased 1.04% from the previous year. In 2023, adoptions from foster care made up 46.44% of total adoptions, while private domestic adoptions made up 51.57%, and intercountry adoptions made up 1.99%. The total number of adoptions from foster care was 723, which decreased 11.07% from the previous year. The total number of private domestic adoptions was 803, which increased 18.44% from the previous year. Lastly, the total number of intercountry adoptions was 31.

In 2022, an estimated 1,541 children were adopted in Washington. This decreased 16.48% from the previous year. In 2022, adoptions from foster care made up 52.76% of total adoptions, while private domestic adoptions made up 44%, and intercountry adoptions made up 3.24%. The total number of adoptions from foster care was 813, which decreased 19.02% from the previous year. The total number of private domestic adoptions was 678, which decreased 12.63% from the previous year. Lastly, the total number of intercountry adoptions was 50.

In 2021, an estimated 1,845 children were adopted in Washington. This decreased 3.15% from the previous year. 

West Virginia

In 2023, an estimated 1,840 children were adopted in West Virginia. This decreased 15.67% from the previous year. In 2023, domestic adoptions made up 99.84% of total adoptions, while intercountry adoptions made up 0.16%. Data on adoptions from foster care and private domestic adoptions are not yet available. The total number of intercountry adoptions was three.

In 2022, an estimated 2,182 children were adopted in West Virginia. This decreased 7.58% from the previous year. In 2022, adoptions from foster care made up 83.91% of total adoptions, while private domestic adoptions made up 15.9%, and intercountry adoptions made up 0.18%. The total number of adoptions from foster care was 1,831, which decreased 1.35% from the previous year. The total number of private domestic adoptions was 347, which decreased 30.46% from the previous year. Lastly, the total number of intercountry adoptions was four.

In 2021, an estimated 2,361 children were adopted in West Virginia. This increased 22.2% from the previous year. In 2021, adoptions from foster care made up 78.61% of total adoptions, while private domestic adoptions made up 21.14%, and intercountry adoptions made up 0.25%. The total number of adoptions from foster care was 1,856, which increased 10.28% from the previous year. The total number of private domestic adoptions was 499, which increased 103.67% from the previous year. Lastly, the total number of intercountry adoptions was six.



In 2023, an estimated 1,514 children were adopted in Wisconsin. This decreased 38.88% from the previous year. In 2023, adoptions from foster care made up 45.44% of total adoptions, while private domestic adoptions made up 53.1%, and intercountry adoptions made up 1.45%. The total number of adoptions from foster care was 688, which decreased 10.77% from the previous year. The total number of private domestic adoptions was 804, which decreased 52% from the previous year. Lastly, the total number of intercountry adoptions was 22.

In 2022, an estimated 2,477 children were adopted in Wisconsin. This increased 61.9% from the previous year. In 2022, adoptions from foster care made up 31.13% of total adoptions, while private domestic adoptions made up 67.62%, and intercountry adoptions made up 1.25%. The total number of adoptions from foster care was 771, which increased 12.55% from the previous year. The total number of private domestic adoptions was 1,675, which increased 106.28% from the previous year. Lastly, the total number of intercountry adoptions was 31.



We are uncertain why this discrepancy between disposition data from the Court System and outgoing case data from CSP existed for 2019 and 2020 but note that the outgoing case data reported by CSP for Wisconsin in 2021–2023 are approximately equal to the numbers reported by the court disposition summaries.

Wyoming

In 2023, an estimated 335 children were adopted in Wyoming. This decreased 6.94% from the previous year. In 2023, adoptions from foster care made up 27.16% of total adoptions, while private domestic adoptions made up 72.84%, and intercountry adoptions made up 0%. The total number of adoptions from foster care was 91, which increased 9.64% from the previous year. The total number of private domestic adoptions was 244, which decreased 8.27% from the previous year. Lastly, the total number of intercountry adoptions was zero.

In 2022, an estimated 360 children were adopted in Wyoming. This decreased 6.01% from the previous year. In 2022, adoptions from foster care made up 23.06% of total adoptions, while private domestic adoptions made up 73.89%, and intercountry adoptions made up 3.06%. 
